An Ordinance adopted pursuant to 1994 Public Act No. 451 to establish special local watercraft controls for Boardman Pond, and to repeal all conflicting ordinances or parts of ordinances.

ORDAINS:

Regulation No. 28 Grand Traverse County

WC-28-99-001 Boardman Pond: SLOW -- NO WAKE SPEED

On the waters of Boardman Pond, a flooding of the Boardman River, all within Section 34, T27N, R11W, Garfield Township, Grand Traverse County, State of Michigan, from a point beginning at the south section line (Hoch Road extended) to Sabin Dam (Cass Road) it is unlawful for the operator of a vessel to exceed a slow -- no wake speed.

The boundaries of the area described immediately above shall be marked with signs and with buoys. All buoys must be placed as provided in a permit issued by the Department of Natural Resources and be in conformance with the State Uniform Waterway Marking System.

This Ordinance shall take effect thirty (30) days after publication as required by law following adoption by the Township Board
