5. Reports (6:02)

a. Commissioner Reports

Schmuckal stated that the Township Board has discussed putting some ARPA funds into the parks.

DeGood stated that the Master Plan update process is still moving along. Bukowski commented that Silver Lake Recreation Area is one of the premier parks in the region.

b. Staff Report/Updates

i. Parks Steward Report (6:05)

Kehoe submitted his report in writing and added that the walking loop at Silver Lake was repaired and pavement was resealed. For the Commons Natural Area, he met with Copper Ridge staff about the proposed trailhead and indicated that ECT has completed the wetlands delineation. Staff are working on the next phase of the River East Recreation Area projects with the Township Engineer. Plans for winterization are underway at all parks.

ii. PD 2023-113 – Grand Traverse Commons Natural Area – October 2023 Updates (6:14)

Hannon provided an update on the Commons Natural Area. The Township received a preliminary score of 365/500 on the MDNR grant application, and staff met with the MDNR grants coordinator to walk the proposed trail loop. ECT has completed the wetlands delineation and Gourdie-Fraser will work on the boundary survey. The mountain biking subcommittee is scheduling a work bee for October 22 to install signage. Potential designs for the trailhead area at Copper Ridge are being evaluated.

6. Old Business

a. PD 2023-113 – 2024 Parks Priority Projects – Recommended Project List (6:16)

Hannon reviewed 2024 parks priority projects and the estimated budget for these projects. The local match for the Commons Natural Area grant was taken off the priority list because if awarded, grant funds may not be received until late 2024. Commissioners discussed requesting funds in the priority list for the engineering, design, and survey work for the grant application since this portion of the work could potentially begin as soon as the grant funds are received.

Remy moved and Scott seconded to RECOMMEND to the Township Board the list of priority Parks and Recreation projects for 2024, subject to the following:

- 1. Staff will review the budget for the Red Drive Trailhead Engineering and Design with the Township Engineer
- 2. Add in Engineering, Design, and Survey Work for the Commons Natural Area Accessible Trail project
- 3. List projects in priority order
