

FROM THE ASSESSOR'S OFFICE

Did you participate in the 2020 Census? It appears that most of the Township residents did. Garfield Township has grown by 19.9% since 2010, the largest increase in Grand Traverse County. And, if you've been paying attention, you have noticed the traffic and seen all the new construction that has lead up to this!

2021 continued the 2020 trend for a high volume of new Construction and Sales activity - not just residential property but also commercial and industrial properties. And, values have definitely increased too. Buyers need to understand how property values are calculated after a purchase so they can decide if they are able to afford the property they want to buy. We can help by explaining how property taxes are affected by a purchase.



The Assessed Value (AV) is our attempt to reflect 50% of the true cash value of the property. Since the AV is supposed to reflect 50% of that, one would expect it should now become 50% of the sale price, but the law does not allow us to *automatically* assess at this value. Everyone home in a given neighborhood are increased, or decreased, by the average difference between the AV and the sale prices of all properties that sold in that area.

The Taxable Value (TV) is a comparison between the Capped Value (CV) and the AV. The "capped" value calculation uses last year's TV times the lesser of the CPI (Consumers Price Index) or 5% - UNLESS the property sells, something new is built or demolished. Then the AV and CV are compared, and the TV becomes the lesser of the two values. If a property sells, the year after the sale – the TV uncaps and becomes the same as the new AV - meaning the buyer will pay more taxes than the seller did.

These calculations are confusing to most buyers. If you've recently bought a home, added a deck, removed a garage or just want to understand how your values are calculated, feel free to call Justin – he is here to explain how the process works.

Due to the growth in our Township, we were required by the Bureau of Elections to add a precinct. The County added two new County Commissioners. The State House Districts are changing due to the census results.

We will be sending new ID cards to all voters in the coming months with the new information. Please review your ID cards in case your precinct number or location has changed. Our next scheduled elections will be the August Primary on August 2, 2022, followed by the November General Election on November 8, 2022. If you are on the Permanent Absentee Ballot list, please watch for your applications from our office in June and in September. To staff our new precinct, we will need additional election inspectors.

FROM THE PARKS DEPARTMENT

Walking Trails:

While certain areas are winterized (Pickleball Courts & Kayak Launch), a reminder that Silver Lake Recreation Area Walking Trail & Buffalo Ridge Trail will be maintained throughout the winter.

River East Recreation Area will be open through the winter as well. The parking lots will be cleared and there is a nature trail down to the Boardman River off the northwest corner of the property. The pavilion is almost complete for next year's rentals, and the installation of another Dog Park is in the future.

Norm Fred was awarded the Michigan Townships Association Frank Purvis Stewardship Award for his efforts in organizing & volunteering multiple clean-ups in our township parklands. This year alone, Norm Fred's non-profit team of the Boardman River Clean Sweep has brought out over 100,000 pounds of trash either by kayaks, canoes, wheelbarrow or by hand. Additionally, he has collaborated with Harm Reduction of Michigan to retrieve and dispose of more than 1,100 needles.

FROM THE PLANNING DEPARTMENT

Transformation of the former Price Point automobile dealership along US-31 is underway. Four new developments were approved by the Planning Commission for this area that surrounds the existing McDonald's restaurant. A key element of these developments will be a new service drive that will loop all the developments together along with new sidewalks. The first development nearing completion is the Lake Michigan Credit Union building - a 3,300-square foot building with three drive-through lanes. To the east, two hotels have been approved: Tru Hotel by Hilton and Fairfield Inn by Marriott. Combined these hotels will provide 182 rooms. The Tru Hotel is the first hotel under construction at this time. Most recently approved is WellNow Urgent Care which will replace one of the former Price



Point buildings. WellNow, a subsidiary of Aspen Dental, will build a 4,200-square foot medical clinic. The following building elevations are from the approved Tru Hotel and Fairfield Inn.



In the last three years, over 1,000

new housing units have been approved by the Township Planning Commission. Most recently, the multi-family housing developments of South 22 and Marengo 31 were approved. Located at the northwest corner of LaFranier and Hammond Roads, South 22 will provide 216 new apartments. A unique feature will be several one-story quadplexes that provide 3-bedroom/2-bath dwellings with attached two-car garages. Marengo 31 consists of two 30-unit apartment buildings and will be built behind the Baymont hotel on US-31. This location will have the potential to be connected to Miller Creek Nature Reserve and the Mall trail. The following building elevation is from the approved Marengo 31:

FROM THE ZONING DEPARTMENT

Pathways to Nowhere?



If you have had the opportunity to travel through the Township you may have noticed new sidewalks and bike paths being constructed in seemingly random locations along some of our major roadways. While the Township and other agencies have constructed non-motorized facilities, other "random" sidewalks and pathway segments have been installed by adjacent landowners as they develop or redevelop property along major roadways. Our Zoning

Ordinance requires that non-motorized facilities be installed along the frontage of roadways included in our Non-Motorized Plan where substantial improvements are made to a property. As additional properties are developed or redeveloped along these corridors, additional sidewalks and trails will be required to be constructed. The goal is to complete a sidewalk and trail network as envisioned in the Township Non-Motorized Plan. Non-motorized requirements can be found in Section 522 of the Zoning Ordinance. The Non-Motorized Plan can be found in the Township Master Plan. These Plans can be viewed on our website at <u>www.garfield-twp.com</u> or by stopping by our offices.

FROM METRO FIRE DEPARTMENT

Happy Holidays from all of us at Grand Traverse Metro Fire Department. With winter setting in make sure to follow these safety guidelines:

- Have your furnaces, fireplaces and chimneys checked by a professional
- Test your smoke and carbon monoxide alarms
- Keep a proper ABC fire extinguisher in your home accessible for use
- Keep snow clear from all furnace exhaust openings
- Never leave candles burning unattended
- Constantly attend all cooking
- Keep Christmas trees watered daily

- Slippery roads and snow equal increased stopping distance and reduced visibility. Slow down, manually turn on your headlights and drive defensively.

FROM THE SHERIFF'S OFFICE

For those that leave the area for the winter, the Grand Traverse County Sheriff's Office can provide winter property checks. Please stop by the Garfield Township Office to complete the property check form, and it will get assigned to one of the Community Police Officers.

<u>Slow down</u> and allow for extra time to your destination. Snow tires make a huge difference for safe winter travel. Also, have

some essential items in your vehicle in case you get stuck: shovel, sandbag, blankets, flashlights and jumper cables.

A reminder of the County Winter Parking Ordinance #13:

The purpose of this ordinance is to prohibit the parking of motor vehicles on public roadways and shoulders of Grand Traverse County during the winter season, December 1 to March 31 of the following year, between the hours of 12:00 a.m. (midnight) and 8:00 a.m. and snow emergencies, in order to facilitate snow removal, general highway maintenance and to eliminate obstruction, hazardous and undue interference with the free movement of traffic caused by the parking of vehicles upon the public highways.
