## 5. Reports (6:03)

## a. Commissioner Reports

Schmuckal reported that there was a special board meeting at which the River East Recreation Area bathrooms were addressed, and a new ADA compliant model was ordered to include a urinal for the men's bathroom. Schmuckal also indicated that the Board turned down BATA's request for building occupancy. DeGood added that the Township Master Plan was approved by the Board. Scott stated that he hiked near Miller Creek and shared concerns about signage and lack of shade for benches.

## b. Staff Report/Updates

## i. Parks Steward Report (6:14)

Kehoe submitted his report in writing and said that pickleball courts are being considered at Silver Lake Recreation Area and that Staff may ask for a quote for this project. Benches were ordered for the dog parks. Staff have removed old trash cans at Boardman Valley Nature Preserve which were deteriorating. A new bench has been installed on the Buffalo Ridge Trail near the senior living facility.

Hannon commented that the trail maps at each of the parks can be updated this winter once the Township completes its branding and website update project. Hannon also stated that the updated maps for the Commons Natural Area will account for the new trailhead at Copper Ridge.

## 6. <u>Old Business</u> (6:19)

a. PD 2024-57 – Copper Ridge Trailhead Conceptual Design – Continued Commissioners reviewed a conceptual drawing for this project at the June 3, 2024 meeting. Since then, Staff have conducted an onsite visit with the Township Engineer, Gourdie-Fraser (GFA), and members of the mountain bike subcommittee. GFA prepared an updated conceptual drawing for the project based on feedback following the site visit and this updated drawing was provided to the Parks and Recreation Commission.

The updated drawing was also shared with representatives of the Copper Ridge Surgery Center and Copper Ridge association. They provided their comments to Staff and indicated a preference for a preference of avoiding routing the trail on their property, and asked if bathrooms were part of the proposed amenities. Staff replied to the representatives' comments.

Commissioners discussed the proposed project and suggested that there should be two RFPs prepared: one for the parking lot / trailhead area and one for the trail.

Schmuckal moved and Remy seconded TO RECOMMEND to the Township Board that two Request for Proposals (RFPs) be published for the Copper Ridge Trailhead project.

### **BACKGROUND:**

In December 2023, Garfield Township was informed that its grant application for \$300,000 for an accessible trail at the Grand Traverse Commons Natural Area was recommended for funding by the Michigan Natural Resources Trust Fund (MNRTF) Board of Trustees. In September 2024, the Michigan Legislature passed legislation with the 2023 grants recommended by the MNRTF Board; this legislation is awaiting signature by the Governor. Once this occurs, the Michigan Department of Natural Resources (MDNR) will receive the authorization to issue Project Agreement contracts. The terms of the Project Agreement will need to be adopted by resolution by the Township Board.

Meanwhile, the following steps can be taken before the project agreement is completed. Staff have been working on completing several of these steps; an update is provided as follows:

## Prepare a legal description and boundary map of the project area

- Staff have prepared a boundary map (see attached)
- The Township Assessor has prepared the legal description and sketch (see attached)

## Finalize any lease, easement, or use agreements

• The Township owns the entirety of the Commons Natural Area, though there are some existing conservation easements and a historic easement. These easements are depicted on the boundary map.

### Make sure local matching funds are in place

• The Township Board passed a resolution on March 14, 2023 supporting the grant application and committed to using up to \$368,100 in Township matching funds as a 55% local financial match to the project. The funds would be allocated from the Township budget to the Park Fund. Some matching funds are used to cover the engineering portion of the project as described below. The remaining matching funds would cover the rest of the project, which is being considered as a 2025 priority project by the Parks and Recreation Commission.

#### Retain the services of a Prime Professional

- The Township's Engineer of Record, Gourdie-Fraser (GFA), provided a proposal for engineering services to the Township Board which was approved at their March 26, 2024 meeting. GFA will function as the Prime Professional on this project.
- GFA completed a boundary survey of the property in 2023 which will be used for this project.

#### Prepare plans, specifications, and bid documents

• GFA's proposal includes preparation of the engineering plans, specifications, and bid documents. GFA is working on the preparation of these materials.

## **Begin securing required permits**

- Environmental Consulting & Technology, Inc. (ECT) completed a wetland delineation of the project area in 2023 which will be used when applying for wetland permits from the Michigan Department of Environment, Great Lakes, and Energy (EGLE).
- Based on the wetland delineation, there are some potential adjustments which could be made to the proposed trail route to minimize impact on the wetlands. GFA is working on adjusting the proposed route as part of preparation of engineering plans before applying to EGLE for permits.

• Staff also spoke with EGLE department staff and determined that an on-site pre-application meeting would not be needed since it is already known that a permit will be required.

## Prepare a resolution to be adopted by the Township Board

• Staff are preparing a draft resolution for the Township Board in anticipation of the project agreement. This draft resolution is partly based on a sample resolution provided by the MDNR.





Subject:	2025 Parks Priority Projects – Discussion					

## **OVERVIEW:**

Annually, the Parks and Recreation Commission recommends a list of priority parks projects for the next year to the Township Board. The Township Board receives this list as part of gathering information for the budget process. Projects from this list or identified in discussions during the budget process form the basis of the capital outlay portion of the parks budget.

The Parks and Recreation Commission discussed the preliminary list of 2025 priority projects during their August 5, 2024 meeting. Projects discussed included the accessible trail at the Grand Traverse Commons Natural Area, pickleball court resurfacing at Boardman Valley Nature Preserve, and a potential pickleball court area at Silver Lake Recreation Area. Details on these projects are as follows:

## • Accessible Trail Loop (Grand Traverse Commons Natural Area)

At their March 26, 2024 meeting, the Township Board approved a proposal from the Township Engineer, Gourdie-Fraser (GFA) for engineering services for the accessible trail loop at the Grand Traverse Commons Natural Area in the amount of \$77,500. The total local match for the grant is \$368,100 as identified in the grant application. The anticipated cost attributed to the park budget for construction of the trail loop and other non-engineering expenses is \$290,600.

## • Pickleball Court Resurfacing (Boardman Valley Nature Preserve)

In early 2024, the Parks and Recreation Commission discussed resurfacing the pickleball courts at Boardman Valley Nature Preserve. The Township received a price guarantee from Hentco LLC for this project of \$34,283.

#### • Potential Pickleball Courts (Silver Lake Recreation Area)

Staff have heard from some residents who are advocating for installing pickleball courts at Silver Lake Recreation Area. The Silver Lake Recreation Area Park Development Plan, which is part of the Township's Five-Year Parks and Recreation Plan, shows an area between the existing tennis courts / basketball courts and the paved trail loop which could potentially house these courts. At their previous meeting, the Parks and Recreation Commission and Staff discussed the project and agreed that the area near the playground would be a better location for the courts. Staff estimate the cost of this project to be \$130,000.
